	FEE	DOCUMENT	WHAT IS THIS?
1.	75.00	Durable Financial Power of Attorney	A document that tells folks who is to handle your financial matters when you become incapacitated or unable to manage your own affairs
2.	75.00	Durable Health Care Power of Attorney	A document that tells folks who is to handle your medical decisions when you are no longer able to make those decisions
3.	75.00	Durable Mental Health Care Power of Attorney	A document that tells folks who is to handle your mental health care decisions when you are no longer mentally competent to do so
4.	75.00	Living Will	A document that tells folks whether or not you want to have life-saving or heroic measures when you are comatose, in a vegetative state, or in a terminal condition
5.	0.00	Do Not Resuscitate form/orange paper	A document that tells paramedics and medical personnel NOT to revive you
6.	250.00	Life Care Planning (single person)	Documents 1-4 above for a single person
7.	400.00	Life Care Planning (couple)	Documents 1-4 above for a couple and the signing is done at the same location
8.	500.00	Life Care Planning (couple)	Documents 1-4 above for a couple and the signing is at different locations for each person
9.	100.00	Deed (Quit-claim, beneficiary, disclaimer)	A document recorded with the county recorder indicating a change in ownership now or at death Fee includes county recording fee
10.	999.00	Estate Planning Portfolio (single)	Revocable Living Trust, Financial and Medical Powers of Attorney, Living Wills, Pour-Over Will*, Trust instructions and one item placed into trust (usually people choose their home property).
11.	1499.00	Estate Planning Portfolio (couple)	Revocable Living Trust, Financial and Medical Powers of Attorney for both, Living Wills for both, Pour-Over Wills* for both, Trust instructions and one item placed into trust (usually people choose their home property).
12.	250.00	Miller Trust Basic package	Special Needs Trust – income-only trust used to create income eligibility for ALTCS
13.	400.00	Miller Trust Standard package	Special Needs Trust – income-only trust used to create income eligibility for ALTCS
14.	750.00	Miller Trust Premium package	Special Needs Trust – income-only trust used to create income eligibility for ALTCS
	0.20	Per mile	Round-trip home visit fee
